## ◆ AUDIENCE

This Summer University focuses on students having completed their legal studies' cycle, on professor and on professionals.

## ◆ LOCATION and DATES

The Summer University is held in Paris, at the Sorbonne for 3 weeks, from **Tuesday 2 to Friday, July 19, 2013**.

The application form must be submitted to the Foundation, by the form available on the website [www.fondation-droitcontinental.org](http://www.fondation-droitcontinental.org), no later than **March, 31 2013**.

The selection of candidates is made under the authority of the Scientific Council of the Foundation.

## ◆ TRAINING SESSION

The training session lasts three weeks and includes a total of **55 class hours**.

The training provide courses in **English** and in **French**, the attendees are invited to choose the language.

The courses are taught by high-level specialits, international eminent in continental law and in comparative law.

Professional conferences are scheduled so as to provide even greater depth of the course materials.

The lessons are :

- The Civil Law Systems in a Comparative Perspective
- European and International Contract Law
- Settlement of International Disputes
- Family Law
- Intellectual proprerty
- Civil Liability Law Compared

## ◆ CERTIFICATE

Exams are mandatory for students and optional for the other participants. A certificate of Completion of Training in Continental Law will be issued by the Summer University.

## ◆ CULTURAL ACTIVITIES

The training is accompanied by cultural activities including visiting the highest institutions of the French law (such as Court of Cassation, the Council of State, the Senate, etc.), Institut de France.
