

PROJECT RATIONALE

The Power of L.A.W., the first edition of a new event in the OHADA region, will be held in Lomé, the capital of maritime and financial activities.

The Power of L.A.W. is an annual week of activities designed to bring together maritime and financial arbitration practitioners from all over the world in Lomé, whose strategic position has already enabled it to host a platform for the African financial industry (AFIS).

The Power of L.A.W is an event designed to build a powerful link between operators, users, institutions in the maritime and financial sectors and arbitration practitioners. The event also aims to create a historic framework for professionals to listen to each other, and to connect young practitioners, the heirs of tomorrow's maritime and financial arbitration.

The Power of L.A.W. is a forum for high-level doctrinal debates and edifying workshops led by internationally renowned professionals.

The Power of L.A.W. is an event designed to promote arbitration and mediation as means of settling maritime and financial disputes.



THE PROMOTEUR

reated in 2019 by the Association Internationale pour le Développement de l'Arbitrage en Afrique (AIDAA), the Centre International d'Arbitrage et de Médiation (CIAM) has established itself as an internationally renowned institution specializing in the settlement of maritime and financial disputes.

The idea of a center specializing in the settlement of financial and maritime disputes arose from the founders' desire to respond to a real need to offer economic operators in these sectors appropriate and effective dispute settlement methods.

The Center launched its activities at an international symposium on arbitration of maritime and

financial disputes held in Lomé on April 28 and 29, 2022, which brought together a number of high-profile participants.

Its first arbitrators and mediators were selected following a training course organized in September 2023 in Lomé, following an international call for candidates.

PROJECT RATIONALE

The project has two components:

Firstly, because of its strategic position for the development and operation of maritime and financial infrastructures useful to the sub-region, the Port Autonome de Lomé (PAL) welcomes the latest generation of ships.

Whether they are brokers or charterers, managers or agents, shipowners or insurers, freight forwarders, port logisticians, port operators, customs representatives or simple users, maritime trade operators are all involved in using port infrastructures to transport goods to and from their destinations.

With over 90,000 ships (oil tankers, container ships, roll-on/roll-off vessels), sea freight is the most important mode of transport for shipping goods internationally.

The total volume of goods traded internationally represents around eleven (11) billion tonnes per year. UNCTAD has indicated that maritime trade grew by 1.4% in 2022, and that this trend will average 2.1% per year over the period 2023-2027, and multiply by 4 by 2050.

Today, PAL is seen by many as an interconnection link between Africa and the rest

of the world, putting Lomé in a unique and sustainable position to improve delivery times and support the economic development of countries in the subregion.

One shipowner had no hesitation in revealing his ambition to strengthen his presence in Africa from Lomé: "A dematerialization of processes between sea, land and the customer, combined with collaboration with the partners and administrations concerned, will make it possible to help shape a more sustainable future for Africa and the planet."



Consequently, disputes relating to maritime activities, whether they concern ship operation and management, navigation, goods transport, repairs, commission, logistics, sales, charter parties, insurance, etc.... very often involve African parties, while at the same time being international in nature.

Yet, for a very long time, maritime arbitration has been the usual means of settling disputes in this field. African parties therefore need to "domesticate" maritime arbitration as a means of settling disputes involving them.

Secondly, Lomé's dominant position as the headquarters of sub-regional financial institutions such as BOAD, BIDC, ETI, AGF and CICA-RE, and its proximity to the regional stock exchange in Abidjan, reinforces reflection on the effectiveness and appropriateness of arbitration

procedures for disputes in the complex fields of banking and financial law.

Major players are increasingly realizing that arbitration is better suited to disputes in banking and finance, and recognize that the characteristics of this procedure effectively complement the range of dispute resolution mechanisms available in the OHADA area, while contributing to the zone's attractiveness.



In these circumstances. CIAM has decided to bring together in Lomé all the players in the maritime, banking and financial sectors. together with their clients and partners, in a major event entitled The Power of L.A.W. to discuss, over the course of a week, the justifications for settling maritime and financial disputes in Africa by means of arbitration and mediation. addressing issues specific to each sector of activity and those of commercial and investment arbitration.


Finally, based on the principle that no arbitration centre can develop without the action of the State in its role of regulating and creating an attractive legal and legislative framework, the organizers of this unprecedented event and their partners intend to arouse the interest and support of the public authorities in order to create a modern and innovative

legal framework likely to appeal to the increasingly demanding international arbitration ecosystem.

The aim is not only to complete the legislative arsenal promoted by the OHADA treaty and its uniform acts, but also to envisage the establishment of an international jurisdictional body involving professionals, before which parties can confidently lodge appeals for annulment

The Power of L.A.W is intended to be a week during which legal practitioners, business leaders, investment support institutions, financial institutions, development partners and regional and international experts will reflect, in a spirit of exchange and partnership, on the opportunities for making Lomé a privileged location for the settlement of maritime and financial disputes through arbitration and mediation.


